Dunstan as the boy hailed from Pavaratty, I asked him to send his Hall Ticket and a request letter to the Principal, directly to me in whatsapp. With the sole faith that Fr. Dunstan will do a miracle, then itself, I told Denny to reach the college by 12.30 pm to begin his exam. The night went with faith and prayers. Early morning, I took leave, went to Denny's home and prayed for his grandfather. The previous day, by 11 pm, I had sent the letter to the Principal and CE with the required documents, requesting permission to anticipate the time of examination by a few minutes so that Denny could complete the exam and reach the funeral venue. In the morning on 7/7/2022, I personally telephoned the CE for a favourable response and the CE told the he will discuss it with the Principal and inform. By 11 am, I got the call from Dr Anto P. V. to ask Denny to come to special room to write the examination, ahead of time. At the same time, Denny blindly following my instruction, had started early from his home and reached college by 12 noon itself. As permission was granted to write the examination early,

in a special room, Denny could write the examination for two hours; hence, he could complete the exam, and leave the hall earlier, and could pay last tributes to his beloved grandfather. We thankfully acknowledge the heavenly intercession of Fr. Dunstan, and the special favour granted to Denny to write the examination and participate in the funeral of his grandfather.
